## HM Revenue & Customs wants to give us free money!

***Please sign the Gift Aid form below and send it with your application to the Membership Secretary.***

For every £1 you donate and/or pay towards your membership subscription HM Revenue & Customs will add another 28p for free.

The only condition is that you must be paying Income Tax (or Capital Gains Tax) at least equal to the amount claimed by the Kendal Civic Society and any other charities you support through Gift Aid during the tax year. This is because Gift Aid comes from the tax you have paid.

For example if your membership fees/donations to the Civic Society *plus other charities operating Gift Aid* totalled £50 per year, then you need to be paying at least £50 x 0.28 = £14 tax per year.

If so, all you need to do is sign the Gift Aid Declaration form overleaf and give it to the Treasurer. It really is that simple.

If all members signed the form below that would add over £500 to the society's funds each year - for nothing! We could do a lot with that.

If you later find you no longer pay enough tax to cover your charity donations, or you change your name and address, please just put it in writing to the Treasurer.
